- OFF-PEAK** : **£95** (Permitted to play Mon – Fri, 9 am to 5 pm only)
- COUNTRY** : **£95** (Reside 25 miles or more from the club by shortest road route)
- SENIOR CITIZEN** : **£95** (Aged 65 or over in the membership year)
- INTERMEDIATE** : **£95** (Under 25 or improved junior under 18, invited to play at senior level)
- JUNIOR** : **£75** (Aged 10 - 18)

Tax claimed by the charity or CASC

- The charity or CASC will reclaim 28p of tax on every £1 you gave up to 5 April 2008.

- The Government will pay to the charity or CASC an additional 3p on every £1 you give between 6 April 2008 and 5 April 2011. This transitional relief for the charity or CASC does not affect your personal tax position.
